

BISHOP WORDSWORTH'S SCHOOL

16 - 19 BURSARY

1. The 16 to 19 Bursary Fund made available by the Government provides financial support to help students overcome specific barriers to participation so they can remain in education.

2. ELIGIBILITY

To be eligible to receive a bursary the pupil must be aged over 16 and under 19 on 31 August in the academic year in which they start their 6TH Form programme of study and must satisfy the residency criteria in EFA funding regulations. Pupils aged 19 or over are not eligible for the vulnerable student bursary and are only eligible to receive a discretionary bursary if they are continuing on a study programme they began aged 16 to 18 or if they have an Education, Health and Care Plan. To continue to receive a bursary the pupil must satisfy the following conditions:

- a. The pupil's punctuality must be good.
- b. The pupil's level of unexplained absence from all lessons and registration must be no greater than 10%.
- c. There must be no unauthorised absences from either lessons or registrations.
- d. The pupil must not have broken the terms of any Sixth Form contracts that apply.

BURSARY TYPES

3. There are two types of 16-19 bursaries: Vulnerable and Discretionary..

4. **Vulnerable Bursary Type.** Up to £1,200 a year for pupils in one of the defined vulnerable groups below.

a. **Eligibility.** Students must be in one of the defined vulnerable groups:

- (1) In care.
- (2) Care leavers.
- (3) In receipt of Income Support, or Universal Credit in place of Income Support in their own right.
- (4) In receipt of Employment and Support Allowance or Universal Credit and Disability Living or Personal Independence Payments in their own right.

b. **Amount Payable.** A maximum of £1200 per year: £300 in the Autumn Term, £600 in the Spring Term and £300 in the Summer Term.

5. **Discretionary Bursary.** A bursary to meet individual needs, for example, help with the cost of transport, meals, books and equipment.

a. **Eligibility.** To be eligible for the discretionary bursary, pupils must be facing financial barriers to participation and need help to stay in education. Pupils apply for funds for specific educational purposes. The following are defined as specific educational purposes:

- (1) Costs of transport.
- (2) Books and equipment.
- (3) Educational trips – curriculum related trips will be given priority.
- (4) Costs of attending university visits and interviews.

b. **Amount Payable.** A maximum of £600 per year: £200 in the Autumn Term, £200 in the Spring Term, £200 in the Summer Term.

APPLICATION ASSESSMENT & PAYMENT

6. Deadline for Applications.

- a. The last day of September for the October Panel.
- b. The last day of January for the February Panel.
- c. The last day of April for the May Panel.
- d. However applications will be considered after the end of April in cases where financial needs arise later in the academic year.

7. **Claim Assessment.** A Remissions Panel will assess each claim and authorise payments up to the permitted maximum in each term. No pupil will receive more than £600 per year. The Remissions Panel will sit in October, February and May. It will consist of a member of the Sixth Form Office Team, a member of the Finance Office Team and the Head

8. **Method of Payment.** Payments will be made in arrears in October, February and May; normally by BACS transfer to the pupil's bank account.
